Special guest Atty. Michael Henry Yusingco, of the Ateneo's School of Government, joined by host Atty. Gwen Pimentel-Gana of the Pimentel Institute for Leadership and Governance, focused

Federalism talks gain momentum in Iligan City From Page 1

The sustained federalism discussions was joined by students, faculty, and guests, of Mindanao State University in Iligan.

The activity was under the auspices of the Hanns Seidel Foundation Philippines and the Pimentel Institute for Leadership and Governance.

The event provided a platform for generating a momentum on federalism talks, emphasizing its value and challenges in the context of Philippine political development.

Under the moderation of Prof. Melba Angni, assisted by Ms. Clarisse Aquino, the seminar kicked off with Atty. Elmar Martin Jay Dejaresco's discussion on the Basic Powers and Structure of the Philippine Government. The focus was on the present government settings, highlight the deeply centralized system pervading in the Philippine political structure.

He emphasized the key features of unitary government and powers. Dejaresco highlighted the concentration of vital powers in the national government, shaping decisions at other government levels.

Dr. Manuel Jaudian, the second speaker, delved into the applicability of federalism to the Philippine setting.

Explicitly distinguishing concepts from earlier discussions, he explored debates on unitary versus federal systems, devolution versus shared powers, and exclusive taxation versus shared taxation.

Prof. Edmund Tayao, the third speaker, provided clarity on federalism's goals, addressing issues of self-determination, conflict resolution,

and its potential as a political solution for diverse groups within the country.

The fourth speaker, Atty. Luis Ma. Gil Gana, discussed the intersection of Federalism and Human Rights, emphasizing their compatibility and mutually reinforcing objectives.

The open forum session reflected strong student interest in federalism, fostering enthusiasm to comprehend the concept further. The seminar encouraged participants to broaden discussions about federalism to increase awareness and deepen understanding of its benefits, issues, and challenges.

Resource persons addressed participants' concerns, leading to meaningful discussions.

Participants confirmed the usefulness and relevance of the information provided, identifying challenges in introducing a federal system in the country.

The seminar concluded with participants expressing strong support

- September 7, 2023 Seminar on federalism were done in Marawi City one of the cities under the regional government of the Bangsamoro Autonomous Region in Muslim Mindanao. The venue of the federalism seminar was the main campus of the Mindanao State University and and participated by 169 attendees, students, faculty and guests.
- November 22, 2023 Continued discussions on federalism were conducted in Marawi State University- Iligan Institute of Technology, Iligan City last November 22, 2023, with 166 attendees, students, faculty and guests, including student leaders from MSU-Naawan.

Research, Italy, a groundbreaking virtual program, a cross-continental exchange took place between a panel of speakers on the issue of regionalism in both Italy and the Philippines.

5. Held last August 18, in Germans Club, Makati and September 15, in Cgayan de Oro City. Some were in physical attendance and others are via zoom. The attendees were the scholars of the PILG-HSF in various federalism conferences abroad.

It was productive exchange with directions suggested for consideration for future activities such as the use of the Bayanihan Draft Constitution as submitted by the Consultative Committee.

This would bring the discussion to Visayas and tapping local experts who speak the language to help promote better understanding and open discussion; and the possible integration of federalism as a subject into the academic curriculum.

The PILG looks forward to future collaboration with our programs and projects on Federalism and Local governance with the unwavering support of Hanns Seidel Foundation to sustain and expand programs on Federalism and Local Governance.

MARAWI CITY GAB SPURS ENTHUSIASTIC SUPPORT FOR FEDERALISM ADVOCACY

Marawi City, situated within the Bangsamoro Autonomous Region in Muslim Mindanao, recently hosted a dynamic federalism seminar at the main campus of Mindanao State University.

Attended by 169 participants, the event spearheaded by the Aquilino Q. Pimentel, Jr, Institute for Leadership and Governance (PILG) featured speakers who discussed critical aspects of federalism, generating enthusiasm and support for its adoption in the Philippines.

The activity was under the initiative of the Hanns Seidel Foundation Philippines, which is pushing for sustained discussion abut federalism.

Dr. Jaudian a well-known media personality in Mindanao, emphasized

the need for the voices of people, especially those distant from the central government, to be heard and recognized.

Federalism expert Prof. Edmund Tayao provided clarity on federalism's goals, focusing on issues of selfdetermination, conflict resolution, and its potential as a political solution for diverse groups within the country.

Atty. Francis Tom Temprosa, a legal expert in the field of human rights, discussed the possible changes in life due to federalism, highlighting its implications for human rights protection and promotion.

He underscored federalism's link to self-rule, autonomy, and democracy, asserting that it can promote democratic principles and respect for human rights.

Post-seminar, an evaluation form gauged participants' understanding, leading to a post-evaluation meeting.

The consensus was to continue such discussions on federalism, recognizing it as a significant way to deepen understanding, highlighting both advantages and challenges.

Participants suggested conducting more forums nationwide, especially in schools, to help the youth comprehend federalism as a system of government. With ongoing support, the hope is to navigate towards the goal of implementing a federal form of government in the Philippines, with potential collaborations with institutions like MSU for future seminars.

on the theme, "Understanding Barangay and Local Governance."

The podcast emphasized key points related to the crucial role of Barangay in the democratic process and the responsibilities of engaged citizenry.

The Key Discussion Points raised were:

- Big Responsibility of Voters: Participating in elections is a significant responsibility for voters.
- Value of Barangay: Atty. Yusingco emphasized the importance of understanding the value of Barangay.
- Front Line of Government: Barangay serves as the front line of the government, embodying a kapitbahaynan culture focused on the community.
- Non-Partisan Elections: Barangay elections are deemed non-partisan, and the primary role is to represent the community, not a political party.
- Candidate Requirements: Anyone meeting the basic legal requirements can run for Barangay, but a good and viable program for the community is crucial.
- Anti-Dynasty Provisions: The new SK



law includes anti-dynasty provisions, promoting fair representation.

- Choosing Candidates: Voters should prioritize candidates with practical, creative, and attainable goals for the community.
- Viable Livelihood Programs: Barangays and SKs have funds, and candidates should focus on viable livelihood programs.
- Responsibility of the Community: Barangay is not solely responsible for

everything; the community should actively take responsibility.

The Fed Talk Podcast highlighted the importance of informed and responsible voting, urging citizens to evaluate candidates based on their commitment to the community rather than political affiliations. The podcast emphasized that Barangay belongs to the people, and citizens should actively engage in local governance.

REGIONALISM IN THE PH HIGHLIGHTED IN PODCAST

Regionalism in the Philippines, an often overlooked, but crucial aspect of governance, was highlighted in a thoughtprovoking podcast aired on November 30, 2023, titled "Fed Talk at the PILG: Local Autonomy and Inter-Regional Governance,"

Atty. Gwendolyn Pimentel-Gana, President of the Pimentel Institute for Leadership and Governance, engaged in a dynamic conversation with guest speaker Atty. Michael Henry Yusingco an expert in the subject of Philipine governance.

The podcast aimed to focus and shed light on the concept of Inter-Regional Governance in the Philippines.

The primary objective of the podcast was to provide a comprehensive understanding of Inter-Regional Governance in the Philippine context

The theme, "Local Autonomy and Inter-Regional Governance," guided the discussions throughout the podcast.

The podcast delved into various aspects of Regional Governance in the Philippines, emphasizing its significance

and challenges in unitary system of government in the Philippines.

Some of the insights from the discussion dealt with Regional governance as a term less commonly used in Philippine governance discourse, but plays a crucial role as a sub-national level of government.

Atty Yusingco emphasized that reginal governance, which is positioned between the central government and local governments, involves smaller political and territorial subdivisions, commonly known as autonomous regions in the Philippines.

He said that the 1987 Constitution allows for regionalism, emphasizing unity among provinces, while regional governance encourages coordination among sub-national entities.

He explained that the provinces, contrary to common belief, do not exemplify regional governance; but are distinct entities as political subdivisions in the Philippine political landscape.

There have been difficulties in putting into operation the reginal governments which are the Bangsamoro Autonomous Regional in Muslim Mindanao or the BARMM and the Cordinaller Autonomous Region.

Challenges in establishing regional governance stem from institutional and political culture differences, creating hurdles in collaborative efforts, Atty Yusingco said.

Advocates for regional governance argue for constitutional amendments or legislative reforms, citing the need for autonomy, akin to the structure of the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM).

Despite challenges, Atty Yusingo said that the importance of pursuing regional governance is to be underscored underscored, citing that emphasizing collaboration and a cooperative approach is needed to address structural issues.

The podcast concluded with a call to action for local government officials to explore the potential benefits of regional governance, stressing the importance of unity and collaborative efforts in shaping the future of governance in the Philippines.

ONLINE SEMINAR EMPOWERS YOUTH FOR FEDERALISM

In a recent online seminar last July 8, 2023, twenty two (22) Batang Transformer Alumni participated in a comprehensive discussion on federalism, aiming to broaden the knowledge base of this system of government in various sectors of Philippine society.




